RESULTS OF LAW SOCIETY ELECTION 2021

Senior Category

There are 4 places in the Senior Category and the 6 candidates for the Senior Category are, in random order, Sam Hui Min Lisa (Lisa Cen Hui Min), Gregory Vijayendran Ganesamoorthy, SC, Chia Soo Michael, Manimaran s/o Arumugam, Ong Boon Hwee William and Rajvant Kaur d/o Jagit Singh.

The results of the Ballot held on Friday, 30 October 2020 are as follows:

Under section 51 of the Legal Profession Act, the elected candidates in the Senior Category are, in random order, Sam Hui Min Lisa (Lisa Cen Hui Min), Gregory Vijayendran Ganesamoorthy, SC, Chia Soo Michael and Manimaran s/o Arumugam.

Sam Hui Min Lisa (Lisa Cen Hui Min), Gregory Vijayendran Ganesamoorthy, SC, and Chia Soo Michael are current Council members and have served in Council since 2011, 2013 and 2010 respectively. Manimaran s/o Arumugam will be a new addition to Council.

Middle Category

There is 1 place in the Middle Category and the 4 candidates for the Middle Category are, in random order, Daniel Tay Yi Ming, Lim Hui Li Debby, Simran Kaur Toor and Goh Keng Haw

The results of the Ballot held on Friday, 30 October 2020 are as follows:

| Name of Candidate | Number of Votes |

| 2) Lim Hui Li Debby | 433 |
| 3) Simran Kaur Toor | 614 |
| 4) Goh Keng Haw | 101 |

Under section 51 of the Legal Profession Act, the elected candidate in the Middle Category is Simran Kaur Toor.

Simran Kaur Toor is currently a Council member and has served in Council since 2011.

Junior Category

There are 2 candidates for 2 places in the Junior Category, and they are Marshall Lim Yu Hui and Abhinav Ratan Mohan . As such, there is no election for the Junior Category this year. Under section 53(1) of the Legal Profession Act, Marshall Lim Yu Hui and Abhinav Ratan Mohan are deemed to be elected.

Marshall Lim Yu Hui and Abhinav Ratan Mohan will be new additions to Council.
